

MDHIN PHARMACY PARTICIPATION AGREEMENT

This Pharmacy Participation Agreement ("Agreement") is entered into between MDHIN Corporation ("MDHIN") and the undersigned Pharmacy ("Pharmacy Provider").

1. PURPOSE

Pharmacy will participate in the MDHIN Network and provide MDHIN member services under the program RxDirectCare, including permitted pharmacy-based clinical encounters.

2. SERVICES UNDER RXDIRECTCARE

Pharmacy may provide the following encounter types where permitted by state law, scope of practice, and CLIA-waiver status:

- Minor-illness / sick-visit support (e.g., cold/flu symptoms, minor acute concerns)
- Wellness visits, nutrition guidance, lifestyle counseling
- Chronic condition support and ongoing monitoring
- Care coordination and consultations (in-person or virtual)
- POCT services**** such as A1C, lipid panel, strep, flu, COVID — *only where permitted and CLIA-waived*
- Test-and-treat services**** (rapid testing + protocol-based assessment)
- Medication review, optimization, and personalized therapy support

****All POCT and test-and-treat services only where permitted by state regulations and only with a valid CLIA waiver.

3. REIMBURSEMENT

- Pharmacy Visit (99429): \$40 per encounter
- POCT (99000): \$15 per test (max 2 per encounter)*
- ICD-10: Z00.00 unless a more specific diagnosis is appropriate
- Modifier 25 required when multiple services are provided
- All claims must include a Visit ID

*POCT tests reimbursed only where permitted, and only if the pharmacy holds a valid CLIA waiver.

4. BILLING OPTIONS

MDHIN Billing Portal using <https://eligibility.calhin.com/> and following the MDHIN billing process after checking eligibility. Using the Billing/Eligibility Portal utilizes the Reimbursement Codes listed above and may be updated as per MDHIN.

These are general categories but can include Follow-up Visits, Sick Visits, Wellness Visits, nutrition counseling and general evaluation and management including medication management that would all go under a visit code including Medicare plan selection and also the POCT Lipid, POCT COVID, POCT Strep which have a separate POCT code and fee.

*POCT reimbursed only where permitted under state law and CLIA.

**PGx and Hearing is paid to the performing laboratory; pharmacy may bill only the associated visit or POCT where allowed

*** BIN Billing when available. MDHIN will notify all participants of availability for BIN billing and instructions will be provided as well as any updates to the codes for submission and any other relevant information.

5. REQUIREMENTS

Pharmacy must maintain an active pharmacy license, CLIA waiver (if performing POCT)*, compliance with HIPAA and MDHIN documentation requirements. eligibility verification prior to service at (<https://eligibility.calhin.com/>) as well as BIN/PCN functionality and bill using processes available through MDHIN.

*All POCT services only where allowed.

6. TERM & TERMINATION

Either party may terminate with 30 days' notice. MDHIN may terminate immediately for cause (fraud, licensure issues, safety concerns, or policy violations).

7. CONFIDENTIALITY

Pharmacy agrees to maintain confidentiality of all MDHIN member information and comply with HIPAA and applicable laws.

8. GENERAL PROVISIONS

Agreement is governed by Delaware law. MDHIN may update reimbursement or program requirements with 30 days' notice. Participation does not create an insurance relationship. Pharmacy acts as an independent provider.
